## Governor's Proposed Budget Hopeful, But Advocacy Needed to Achieve Hospitals' Goals

The \$141.6 billion state budget proposed by Governor Cuomo on January 21, 2015 includes substantial money for hospitals that would, among other initiatives, provide hospitals with much-needed investments in capital and debt restructuring, bridge funding for financially-struggling hospitals, and elimination and/or reduction of some Medicaid payment penalties and taxes on inpatient revenue. It is a good start for the hospital industry, but these and other proposals remain vulnerable throughout the upcoming

negotiation process between the legislature and governor's office – a process now complicated by the removal of Sheldon Silver as the Assembly's leader.

"We are by no means in a safe place yet," said Kevin Dahill, president/CEO of the Suburban Hospital Alliance. "It's imperative that the hospital industry keep the pressure on Albany to ensure that these investments are included in the final budget and previous promises, such as the elimination of the two-percent Medicaid cut, are upheld." - [jlogan@nshc.org](mailto:jlogan@nshc.org); [jlogan@normet.org](mailto:jlogan@normet.org).

# HIT Concerns, Ebola Funding on DC Agenda

Regulators in Washington, DC are leaning toward modifications to the Medicare and Medicaid Electronic Health Record (EHR) Incentive Programs that would reduce some of the reporting burden on hospitals. Separately, officials at the U.S. Department of Health and Human Services (HHS) announced a broad plan in mid-January about how to use the emergency funds for Ebola preparedness and response.

- **Health IT:** On January 29, 2015, the Centers for Medicare and Medicaid Services (CMS) announced its intention to impart more flexibility into the EHR program. The agency is considering shortening the 2015 reporting period to 90 days from the current 365 days. The agency is also considering converting the reporting periods to the calendar year. Both modifications are welcomed by hospitals, as hospitals remain concerned about their ability to meet the current EHR timeline. Of note, it has been very difficult to find other providers technically capable of receiving summary of care documents to meet the transitions of care objective in the EHR incentive program. Without relief from this mandate and full year of use and reporting requirement, hospitals could face financial penalties even while they work assiduously toward compliance. The recently introduced Flexibility in Health IT Reporting Act in the House seeks to achieve similar changes through the legislative process.
- **Ebola Funding:** In December 2014, President Obama approved a \$1.01 trillion spending bill that included \$5.4 billion in emergency funding to combat Ebola internationally and domestically. Of that amount, \$733 million goes to the Department of Health and Human Services Public Health and Social Services Emergency Fund for the Assistant Secretary for Preparedness and Response (ASPR) and of the \$1.8 billion allocated to the Centers for Disease Control and Prevention (CDC), \$571 million will be used for domestic Ebola preparedness. Hospital will be able to apply for funding for costs related to renovation and/or construction of Ebola treatment spaces, as well as expenses for staff training, equipment and supply needs. The HHS plan does not include details about the timing or process by which funds will be distributed. However, it appears that applications for funds will be made available in late February. New York's hospital industry estimates the designated Ebola centers alone have already spent between \$50 million and \$75 million. The Suburban Hospital Alliance will continue to work with the Healthcare Association of New York State (HANY) to ensure New York hospitals receive their fair share of this Ebola money. – [jlogan@nshc.org](mailto:jlogan@nshc.org); [jlogan@normet.org](mailto:jlogan@normet.org).



## SPOTLIGHT ON: *Quality*

On November 13, 2014, The Joint Commission released a list of hospitals recognized by the *Top Performer on Key Quality Measures* program in its 2014 Annual Report. To be named a *Top Performer*, a hospital must:

- Achieve cumulative performance of 95 percent or above across all reported accountability measures
- Achieve performance of 95 percent or above on each reported accountability measure where there are at least 30 denominator cases

- Have at least one core measure set with a composite rate of 95 percent or above and individual accountability measures within the set with a performance rate of 95 percent or above

### ***DSRIP Update . . .***

Twenty-five emerging Performing Provider Systems (PPS) applied to participate in the **Delivery System Reform Incentive Payment (DSRIP)** program. PDFs of the applications are posted on the state's website for viewing and public comment. The comment period ends February 12, 2015. DSRIP Project Plan awards are expected in early March.

In related DSRIP news, the state released the **Capital Restructuring Finance Program (CRFP)** request for applications. The applications were originally due the same time as the DSRIP applications, but the state now extended the Capital Restructuring Finance Program deadline to February 20, 2015. The CRFP is jointly administered by the DOH and the Dormitory Authority of the State of New York. It will make available \$1.2 billion over the next six years for capital projects that aim to enhance quality, financial viability, and efficiency of the healthcare delivery system in New York State. CRFP funding will be made available to DSRIP and non-DSRIP applicants.

## **News Briefs . . . .**

***IRS Financial Assistance Final Rule . . .*** was released by the Agency December 29, 2014. The IRS rule outlines requirements hospitals must meet to maintain tax-exempt status. The final rule implementing Sector 501(r) of the IRS code prescribes federal requirements in these areas: establishment and disclosure of financial assistance policies; limitations on the amounts charged to patients who are eligible for financial assistance; rules governing billing and collection practices; and standards for conducting and publishing a Community Health Needs Assessment. The final regulations did not differ much from the proposed regulations. However, the final rule does not offer special flexibility to hospitals in states like New York where robust financial assistance laws and policies already exist. The rule offers even more detailed standards that all hospitals must meet. The final rule will take effect for taxable years beginning after December 29, 2015.

***Making Use of Surplus Medical Supplies . . .*** is the focus of the Afya Foundation. The organization's executive director, Danielle Butin, spoke about the organization and its humanitarian mission before the boards of NSHC and NorMet. Afya is a unique medical supply recovery organization that collects surplus medical supplies from healthcare centers in the United States and ships these critical materials to public health missions in African and Caribbean nations. Supplies in three categories are accepted: equipment durables that work, but are being replaced with newer technology; dead inventory/consumables that are still within expiration date and not damaged; and operating room or medical floor consumables that were not contaminated during surgery or medical care. ***Information about the Healthcare Workforce*** . . . is needed for the 2015 Nursing and Allied Health Workforce Advocacy Survey sponsored by HANYS. While the 2015 edition continues to include questions on vacancy, turnover, and recruitment and retention of specific health worker titles, the main focus this year is on the emerging workforce (case managers, patient navigators, community health workers, etc.) Surveys were emailed to all members. ### St. Joseph's Medical Center CEO Elected Chair of NorMet

President/CEO of St. Joseph's Medical Center, Yonkers, NY, Michael J. Spicer was named chairman of the board of directors of the Northern Metropolitan Hospital Association (NorMet). The appointment was announced at NorMet's December 1, 2014 board meeting. The two-year term expires January 1, 2017. The CEOs from each of the member hospitals comprise the board of directors.

Spicer is an accomplished healthcare executive and leader with more than 20 years of hospital and long term care experience. Prior to his appointment as CEO in 2000, Spicer served St. Joseph's as executive vice president and chief operating officer and then as its president.

Under Spicer's leadership, St. Joseph's has greatly expanded its clinical programs – both inpatient and outpatient. The medical center was the first in Westchester County to have a Family Residency Program, and it also now sponsors residencies in podiatric

medicine and surgery. Spicer holds a Bachelor of Science degree from Fairfield University and an MBA from St. John's University. He is a fellow of the American College of Healthcare Executives and sits on numerous community organization boards.

"I am happy to assume the role of chairman of the Northern Metropolitan Hospital Association and continue to build on the foundations set by my predecessor, Steve Kelley, CEO of Ellenville Regional Hospital," said Spicer. "I believe the goal of NorMet is to continue to use the resources available through NorMet and our statewide partner the Healthcare Association of New York State to represent hospitals and healthcare providers in our region in the federal and state arenas. In addition, it will be important to foster collaboration within the NorMet region and other regions to meet the needs of a rapidly changing healthcare environment."

NorMet, along with its sister organization, the Nassau-Suffolk Hospital Council on Long Island, form the core of the Suburban Hospital Alliance of New York State, which is the advocacy coalition for all hospitals located in these two suburban regions.

***Excellence in Obstetrics Care*** . . . was bestowed upon Health Quest Affiliate hospitals – **Northern Dutchess Hospital and Vassar Brothers Hospital** – by the New York State Department of Health. The hospitals received the New York State Perinatal Quality Collaborative Obstetrical Improvement Project's 2013 Quality Improvement Award. Northern Dutchess reported fewer than three scheduled deliveries via induction or cesarean without medical indication for all of 2013, while Vassar did the same during the six-month period of July – December 2013.

***Paul Hochenberg*** . . . is the newly named executive director of the **MidHudson Regional Hospital of Westchester Medical Center**. Hochenberg has 42 years of experience in healthcare. He has worked for Westchester Medical for nine years as a member of the senior team.

***Daniel Blum*** . . . assumed the presidency of **Phelps Memorial Hospital Medical Center** on December 1, 2014. He previously served Phelps as its senior vice president. Prior to joining Phelps, Blum served as senior vice president at White Plains Hospital, vice president of operations of the Stellaris Health Network, and administrator of St. Vincent's Hospital and Medical Center in New York City.

## NSHC Events/Meetings Report. . .

**Fiscal Policy Committee:** The committee kicked off its January 14 meeting with a presentation from RelayHealth, a strategic partner of HANYS, about its revenue cycle analytic tools. Ms. Darwell briefed the group on the release of final 501(r) regulations by the IRS, which require changes to hospitals' charity care, billing and collections policies, and provided an update on RAC and two-midnight rule-related audit activity. HANYS vice president of economics and finance Kevin Krawiecki discussed the implications of the State Health Innovations Plan (SHIP) waiver and forecasted the state budget proposal.

**Nurse Executives Committee:** On January 21, the group held a substantive discussion about workforce needs related to the Medicaid waiver programs, particularly the need to reorient existing staff toward outpatient care, care coordination and population health goals, and to expand nurses' scope of practice. Ms. Darwell and Ms. Warner provided policy updates.
